### GENERAL TERMS OF ORDER

- Annex 14 of Chicago Convention provides that the Authority shall prevent the aerodromes from becoming unusable by the growth of obstacles around the aerodromes by establishing a series of obstacle limitation surfaces that define the limits to which objects may project into the airspace hence the Annex shall be applicable to the order.
- 2. For the safety at Joshua Mqabuko Nkomo International Airport, no person shall erect any structure or building within a radius of 9 km from the centre of the runway for any purposes other than for aviation activities done by or for the Authority.
- 3. For ease of reference the prohibited zones as per Annex 14 Table 4–1 are defined as follows
  - (a) Red Zone (Inner Horizontal) for precision approach Categories I and II –4 km.
  - (b) Yellow Zone (Approach Critical Length) –6,5 km.
  - (c) Green Zone (Approach Critical Length) –9 km.
  - (All distances are measured from the centre of the runway)
- 4. Obstacle Zones shall apply to all current and future runways.
