IT IS ORDERED THAT:

1. The applicant Mutumwa Dziva Mawere born 11 January 1960 is a citizen of Zimbabwe by birth in terms of Section 36(1) of the Constitution of Zimbabwe Amendment (No. 20).
2. The 1<sup>st</sup> respondent is interdicted from demanding the applicant to first renounce his foreign-acquired citizenship before he can be issued with a national identity document.
3. The 1<sup>st</sup> respondent is directed to issue the applicant with a national registration document forthwith and in any event before the voter registration process being conducted by the 2<sup>nd</sup> respondent in terms of Section 6 (3) of the sixth schedule to the constitution is concluded.
4. 1<sup>st</sup> respondent pay costs.
