

Customs and Excise (Southern African Development Community)  
(Suspension) (Amendment) Regulations, 2014 (No. 15)

IT is hereby notified the Minister of Finance and Economic Development has, in terms of section 235 as read with section 120 of the Customs and Excise Act [*Chapter 23:02*], made the following regulations: —

1. (1) These regulations may be cited as the Customs and Excise (Southern African Development Community) (Suspension) (Amendment) Regulations, 2014 (No. 15).

(2) These regulations shall come into operation on 1st October, 2014.

2. The Customs and Excise (Southern African Development Community) (Suspension) Regulations, 2002 (hereinafter called “the principal regulations”), published in Statutory Instrument 345 of 2002, are amended in the Second Schedule by the repeal of the following of —
