

Customs and Excise (Designation of Foreign Currency Dutiable Goods) (Amendment) Notice, 2019 (No. 1)

---

IT is hereby notified that the Minister of Finance and Economic Development, in terms of section 115(3) of the Customs and Excise Act [*Chapter 23:02*], made the following notice:—

1. This notice may be cited as the Customs and Excise (Designation of Foreign Currency Dutiable Goods) (Amendment) Notice, 2019 (No. 1).

2. The Customs and Excise (Designation of Foreign Currency Dutiable Goods) Notice, 2019, published in Statutory Instrument 252A of 2018, is amended as follows—

(a) by the insertion of a new subsection after subsection (3) as follows—

“(4) with effect from date of *Gazetting* the persons designated in the Second Schedule to this notice shall be allowed to import the goods with the listed commodity codes being imported entirely for use in their production process in quantities not exceeding the quantities specified against each person listed in the Second Schedule, and pay for the duty in any currency acceptable in Zimbabwe as legal tender.”;

(b) by the insertion of a new Schedule after the First Schedule as follows—
