

Road Traffic (Licensing of Drivers) (Amendment) Regulations,  
2019 (No. 32)

---

IT is hereby notified that the Minister of Transport and Infrastructural Development has, in terms of section 81 of the Road Traffic Act [*Chapter 13:11*], made the following regulations:—

1. These regulations may be cited as the Road Traffic (Licensing of Drivers) (Amendment) Regulations, 2019 (No. 32).

2. Section 12 of the Road Traffic (Licensing of Drivers) Regulations, 1977, published in Rhodesia Government Notice No. 240 of 1997, is hereby repealed and substituted with the following—

*“Prescribed fees*

12. (1) A person applying in terms of section 8(2)(b) or (3) of the Act to an issuing officer for a tractor driver’s permit or duplicate tractor driver’s permit shall transmit with his or her application a fee of twenty-five dollars (ZWL\$25,00).

(2) The fee to be remitted to the Registrar by a farmer or miner or his or her manager or a registering officer in terms of section 8(5) of the Act shall be twenty-five dollars (ZWL\$25,00).

(3) A person applying in terms of section 9(1) of the Act to an examiner for a learner’s license shall transmit with his or her application a fee of one hundred dollars (ZWL\$100,00) for testing the applicant.

(4) A person applying in terms of section 10(1) of the Act to an examiner for a certificate of competency shall transmit with his or her application a fee for testing the applicant of—

- (a) one hundred dollars (ZWL\$100,00) in respect of class 3 or class 4 vehicles; or
- (b) one hundred and twenty-five dollars (ZWL\$125,00.) in respect of class 1, class 2 or 5 vehicles; and
- (c) one hundred dollars (ZWL\$100,00.) for retesting in respect of classes 1, 2, 3, 4 and 5 vehicles:

Provided that upon successful completion of the test for any of the classes above, an applicant shall pay a fee of seventy-five dollars (ZWL\$75,00);

- (d) one hundred dollars (ZWL\$100,00) for duplicate certificate of competency.

(5) A person applying in terms of section 14(1) of the Act to the Registrar shall transmit with his or her application for—

- (a) a duplicate learner's licence, a fee of one hundred dollars (ZWL\$100,00);
- (b) a duplicate driver's licence, a fee of seventy-five dollars (ZWL\$75,00);
- (c) a duplicate driver's licence (urgent), a fee of two hundred and fifty dollars (ZWL\$250,00);
- (d) an original driver's licence (urgent), a fee of one hundred and seventy-five dollars (ZWL\$175,00);
- (e) an international driver's permit, a fee of two hundred and seventy-five dollars (ZWL\$250,00);
- (f) a driver's license search, a fee of twenty-five dollars (ZWL\$25,00).

(6) An examiner receiving a fee referred to in subsections (3) or (4) shall issue to the applicant a receipt in the prescribed form.

(7) A person applying to the Registrar in terms of section 19(1) of the Act for a foreign driver's licence conversion shall transmit with his or her application, a fee of five hundred dollars (ZWL\$ 500,00).”.

3. The Road Traffic (Licensing of Drivers) (Amendment) Regulations, 2009 (No. 31), published in Statutory Instrument 81 of 2009, are repealed.
